
Dear Commissioner Parker

This was the first plebiscite conducted under the provisions of the *Plebiscite Ordinance*, and it was achieved through the efforts of 22 returning officers, as well as deputy returning officers, enumerators, assistant returning officers, poll clerks and a small staff in Yellowknife.

I intend to submit another report of recommendations for modifications to the Ordinance which would facilitate administration of future plebiscites.
