

COMPLIANCE AGREEMENT

I, Arnold Hope, (hereinafter the "Contracting Party"), of the Village of Fort Simpson, Northwest Territories as a Candidate in the electoral district of Nahendeh for the 2015 Territorial General Election on November 23, 2015 in the Northwest Territories agree as follows:

1. The Contracting Party has been served with a demand from the Chief Electoral Officer (hereinafter "the CEO") on July 12, 2016 to pay a penalty of \$250.00 in accordance with Sec. 257.1(1) of the *Elections and Plebiscites Act* (hereinafter "the Act") for failing to make a declaration in the approved form in accordance with s.256(1) of the Act with respect to his election expenses for 2015 Territorial General Election.
2. The Contracting Party did not pay the penalty referenced above within 30 days after receiving the demand from the CEO in accordance with s.257.1(1) of the Act. The penalty has not been paid as of the date of signing of this agreement.
3. The Contracting Party did not make a declaration in the approved form, as is required of him as a Candidate, in the 2015 Northwest Territories General Election.
3. The CEO of the Northwest Territories swore an Information against the Contracting Party alleging offences pursuant to Section 257.1(1) of the Act for failing to pay the \$250.00 penalty after a demand for payment and Section 256(2) of the Act for failing to make a declaration in the approved form no later than 60 days after the polling day for an election. The Information was sworn on November 21, 2016.
4. The Contracting Party shall pay the \$250.00 penalty payable to the Government of the Northwest Territories by submitting payments of at least \$50.00 on each of the following dates: June 9, June 23, July 7, July 21 and July 31, 2017 or until the amount of \$250.00 is paid in full. It is agreed that the Contracting Party may pay the amount in full or any remaining balance of the \$250.00 at any time before July 31, 2017. The payments are payable at the Financial and Employee Shared Services Office of the Government of the Northwest Territories in Fort Simpson, Northwest Territories.
5. The Contracting Party shall submit a complete and accurate Declaration to the CEO in accordance with s.256(1) of the Act no later than Friday, June 30, 2017 at 4:00pm.
6. In accordance with Section 353(1) of the Act, if the CEO is of the opinion that the compliance agreement has been complied with within the time period specified, she shall provide a written notice to that effect to the Contracting Party. If that occurs, the Information alleging offences pursuant to the Act, outlined above, will be withdrawn.
7. In accordance with section 354 of the Act, if the CEO is of the opinion that the Contracting Party has failed to perform the Compliance Agreement or any requirement of the Compliance Agreement, the CEO shall provide a written notice of default to the Contracting Party

informing him that any prosecution that had been suspended by operation of subsection 352(6) may be resumed.

8. The Contracting Party agrees to comply with the Act if he is a candidate in a matter for which the Act applies in the future.


9. The Contracting Party consents to the publication of a notice containing his name, particulars of his breaches of the Act, and a summary of the compliance agreement.


