

## COMPLIANCE AGREEMENT

I, Craig Yeo, of Yellowknife, in the Northwest Territories (hereinafter the "Contracting Party") was a campaign worker for Yellowknife Centre Candidate Julie Green during the Writ period of the 2019 Territorial Election in the electoral district of Yellowknife Centre.

The Contracting Party admits that he did attend Northern United Place, 5004-54<sup>th</sup> Street, Yellowknife NT, on the morning of September 23, 2019 and removed, without authority, campaign signs for Yellowknife Centre candidate Arlene Hache and replaced the signs with campaign materials for Yellowknife Centre candidate Julie Green. The Contracting Party acknowledges that he appears on closed circuit security footage which shows him removing campaign signage of Arlene Hache.

The Contracting Party fully understands and admits responsibility for the act in question that constitutes an offence pursuant to s.296 of the *Elections and Plebiscites Act* (hereinafter the "Act") of the Northwest Territories. This admission of responsibility is done on a voluntary basis.

Prior to entering into this Compliance Agreement with Chief Electoral Officer Nicole Latour, the Contracting Party has given his consent under section 352(3) of the Act to the publication of a notice provided for under s.356 of the Act setting out his name, the act in question and a summary of the Compliance Agreement.


The Contracting Party acknowledges that he will abide by the following terms and conditions of this Compliance Agreement:

- a) The Contracting Party will write personal letters of apology to the following individuals:
  - (i) the two (2) individuals who reside at Northern United Place who made complaints to the Chief Electoral Officer about the offences at issue. These letters will be delivered to the Chief Electoral Officer who will provide them to the two (2) complainants;
  - (ii) Yellowknife Centre candidate Arlene Hache who made a complaint to the Chief Electoral Officer about the offences at issue. This letter will be delivered to the Chief Electoral Officer who will provide it to Ms. Hache;
  - (iii) Yellowknife Centre candidate Julie Green. This letter will be delivered to the Chief Electoral Officer who will provide it to Ms. Green;
- b) As part of the letters mentioned above, the Contracting Party will offer to meet with each Complainant in order to extend a personal apology.
- c) The Contracting Party accepts the condition that he will abide by all provisions of the Act with respect to current and future electoral events administered under the Act.
- d) The Contracting Party consents to the publication of a notice under s.356 of the Act which will set out his name, the act in question and a summary of this Compliance Agreement.


The Contracting Party acknowledges that the Chief Electoral Officer has advised him of his right to be represented by legal counsel and that he has had the opportunity to obtain legal counsel, if he wishes.

The Contracting Party understands that his acknowledgement of an offence pursuant to s.296 of the Act does not constitute a guilty plea in a court of law and that no record of conviction is created as a result of admitting responsibility for the activity that constitutes the offence.
