

COMPLIANCE AGREEMENT

The Union of Northern Workers (hereinafter the "Contracting Party"), as represented by its President, Todd Parsons, hereby enters in to this Compliance Agreement.

The Contracting Party admits that it is a third party for the purposes of the Elections and Plebiscites Act (hereinafter the "Act") that has incurred expenses of at least \$500.00 for election advertising during the election, being the 2019 Northwest Territories General Election. The Contracting Party admits it has placed election advertisements on September 16, 2019 in the Weekend Yellowknifer and on September 20, 2019 in the News/North newspapers. The Contracting Party admits that it did not apply for registration immediately after it incurred expenses of \$500.00 or when it planned to incur expenses of at least \$500.00 in contravention of section 264.2(1) of the Act.

The Contracting Party admits responsibility for the above-mentioned act that constitutes an offence pursuant to s.264.2 (1) of the Act.

Prior to entering into this Compliance Agreement with Chief Electoral Officer Nicole Latour, and as noted below, the Contracting Party has given its consent under section 352(3) of the Act to the publication of a notice provided for under s.356 of the Act setting out its name, the act or omission in question and a summary of this Compliance Agreement.

The Contracting Party acknowledges and will abide by the following terms and conditions of this Compliance Agreement:

- a) The Contracting Party will abide by all provisions of the Act with respect to current and future electoral events administered under the Act.
- b) The Contracting Party consents to the publication of a notice under s.356 of the Act which will set out the Contracting Party's name, the act in question and a summary of this Compliance Agreement.

The Contracting Party acknowledges that the Chief Electoral Officer has advised of their right to be represented by legal counsel and that they have had an opportunity to obtain and seek advice from legal counsel.


The Contracting Party understands that an acknowledgement of an offence pursuant to s.264.2 (1) of the Act does not constitute a guilty plea in a court of law and that no record of conviction is created as a result of admitting responsibility for the activity that constitutes the offence.

Nothing in this Agreement shall be construed so as to preclude the Contracting Party from advocating before a court, with respect to any other matter outside the specific factual scenario as contemplated by this Agreement, any position which may challenge a provision of the Act.
